Approval of the Bylaw Amendment, Article IV, Section 9: Removal which reads:

Directors are expected to attend, at a minimum, all regular BPG Board meetings. Although absences at times cannot be avoided, the Board may remove any Director who fails to attend three (3) such meetings during his/her term. Additionally, the BPG may remove a member with or without cause when it determines that the best interests of the BPG would be served thereby. Removal shall require a super majority vote of the full BPG. Removal shall require a super majority of the full BPG to be present. The BPG Director who is subject to removal may vote.

Donna Lesveque and Cathy Busby will make decisions about what each grade will participate in. There will be no clubs for kindergarten because they go to school half day and need their rest. Approved soccer club and geography club.
